**ORDINANCE NO. 1287, SERIES 2013**

**AN ORDINANCE RELATING TO AMENDMENT OF ORDINANCE NO. 925, SERIES 1986, AS AMENDED BY ORDINANCE NO. 1084, SERIES 1995, CHANGING THE TIME OF CITY COUNCIL MEETINGS FROM 6:00 P.M. (LOCAL PREVAILING TIME) ON THE FIRST MONDAY OF EACH MONTH AND 9:00 A.M. (LOCAL PREVAILING TIME) ON THE THIRD WEDNESDAY OF EACH MONTH TO 6:00 P.M. (LOCAL PREVAILING TIME) ON THE FIRST TUESDAY AND THE THIRD TUESDAY OF EACH MONTH; AND, ESTABLISHING REGULAR MEETING SCHEDULES FOR THE STANDING COMMITTEES OF THE CITY COUNCIL.**

WHEREAS, the Jeffersontown, Kentucky City Council is desirous of setting its meetings to avoid those occasions when the first Monday and third Wednesday occur at times that truncate the time between meetings, and to provide for a more orderly and efficient means to address issues affecting the City.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Jeffersontown, Kentucky as follows:

**SECTION I.**

SECTION I. is hereby Amended as follows:

**SECTION I.**

Regular meetings of the City Council shall be held at 6:00 P.M. (local prevailing time) on the first ~~Monday~~ Tuesday of each month, and at 6:00 P.M. (local prevailing time) on the third ~~Wednesday~~ Tuesday of each month at the City Hall, 10416 Watterson Trail, Jeffersontown, Kentucky 40299; provided, however, if any such meeting date be a State or National holiday, the meeting scheduled for such date shall be held at the time and place provided on the next succeeding day.

**SECTION II.**

The Standing Committees of the Jeffersontown, Kentucky City Council shall hold their regular committee meetings at City Hall, 10416 Watterson Trail, Jeffersontown, Kentucky 40299 on the following days at the following times:

A. First Tuesday of each month, at 5:50 P.M. (local prevailing time):

1. Administrative Committee

- 2. Economic Development Committee
- 3. Parks and Recreation Committee
- 4. Public Works Committee

B. Third Tuesday of each month, at 5:50 P.M. (local prevailing time):

- 1. Finance Committee
- 2. Legislative Committee
- 3. Safety Committee
- 4. Planning and Zoning Committee

However, if any such meeting day be a State or National holiday, the meeting scheduled for such date shall be held at the time and place provided on the next succeeding day.

**SECTION III.**

All Ordinances, or parts of Ordinances, in conflict with this Ordinance are hereby repealed.

**SECTION IV.**

This Ordinance shall take effect and be in full force immediately upon its passage and publication.
